I. Business Operations & Procedures

A. September Financials

- September entries will be processed once registration slows down
- High volume of revenue
- Audit Booked: May 2019

B. Registration

- We are experiencing a number of pending registrations
- An interim report should be available near the end of November

C. Insurance

• Working with Swimming Canada, Provincial Partners and BFL to establish renewal rates/coverage for 2018.

D. Affiliation & Issues:

- ROCS Swimming is under NEW ownership. We are waiting for Proof of dissolution of the old corporation for the club to be in compliance.
- U of Ottawa is affiliating in Quebec
- New Masters' swim club: Team Atomica

E. Office Lease

- The final lease agreement is still with the landlord's legal team
- Updated draft lease should arrive very soon
- S.O. lawyers from Sport Law will review the document again before we sign it.

III. Human Resources

A. Over-flow Staffing

• Stu McLean and Karen Wilson (former Whitby President and Volunteer SO Team Manager) - total 1.0 FTE - have joined the staff to assist with meeting overflow.

B. Staff Employment Agreements

- New staff Employment Agreements compliant with Bill 148 and the Ontario Employment Standards Act have been received and will be distributed to the staff very soon.
- I have a few questions for Ms. Standryk to clarify some detailed concerns before addressing the new EA's with the staff.

IV. Technical Operations/Programming

A. Ontario Swim Academy

- We currently have 7 full-time and 10 part-time swimmers inside the OSA program with 3 frequent out-of-province visitors as part of the OTP Next-Gen Program
 - ✓ Accepting out-of-province visitors is part of our NextGen funding responsibilities
- In 2017-18... 73 athletes from 27 clubs came for at least one visit.
 - ✓ Over 386 daily visitations from those athletes who came back more than once.

B. Performance Pathway Programming (Youth Team Camps)

- Boys Youth Camp: Sept 28-29, 2018 at TPASC
 - ✓ 28 boys (aged 13-15) and 7 coaches attended
- Girls Youth Camp: Oct 12-13, 2018 at TPASC(Scheduled)
 - ✓ 31 athletes (aged 12-14) are confirmed as attending
 - ✓ Guest Coaches are Linda Kiefer and Janet Hyslop
 - ✓ Female mentorship themed camp

C. Open Water Swimming Programming

- Open Water Camp: October 27-28, 2018(Scheduled)
- 8 Swimmers are invited.
- National Open Water Coach Mark Perry will be in attendance

D. Para Swimming Programming

E. Swim Ontario Regional Programming

- Staff has and will continue to be in touch with the Regional Directors to confirm remaining budgets for the 2018-19 fiscal.
- All camp plans will be sent to new Regional Programs Coordinator for approval.
- Swim Ontario staff will coordinate the first Regional Meeting in early November and will be in touch with each Region prior to that Conference Call to firm up the schedule for these meetings.

F. Officials & Officials' Development

- An Evaluator training session was held by SOOC on September 22nd, 2018 during the S.O. Conference.
- A travel subsidy was available to those who attended
- National (Swimming Canada) OCRC Officials' Symposium: Oct 27-28th, 2018 in Toronto. Four SOOC members will attend the symposium to represent Ontario concerns.
- Registered Officials: 1997 including 136 below level 1.
- Swimming Canada has updated all of its on-line clinics based on recent PSO feedback
- Swimming Canada IT enhancements to both the RTR (Registration) site as well as the Education site have caused some service delays and SNAFUs for our membership and registrants.

I. Coaching Professional Development

- 15 NCCP courses are underway
- Coach Compliance is always an ongoing challenge and delicate balance of implementation, enforcement, communication, and patience.
- We currently have 12 registered coaches who have not yet met their PD requirements for a January 2019 deadline. Reminders and suggestions for PD opportunities have been sent directly to them.
- Swimming Canada has launched a new Education site that is currently providing a number of technical challenges. As we communicate daily with the developers and SC staff, things are slowly improving. The new enhancements and the lack of consistent functionality are very frustrating for both staff and registrants, alike.

J. Masters' Swimming

• We are planning a Masters' Swim Clinic for Sunday Dec 16th, 2018, pending confirmation with the Masters' Swimming Committee.

K. Competition Sanctioning

- Clubs are anxious for their meets to be approved and sanctioned for the season, however there are some hurdles slowing down the process:
 - ✓ Dive Start Surveys: Staff have are working diligently with the clubs to get these completed.
 - ✓ Sanction Payment: A lot of declined credit card issues
 - ✓ Coach Registration Coaches slow to complete the process to be in compliance (VSC, CSCTA, etc.).
 - There are 223 meets at various stages of approval in the system so far for the season.
 - It is relatively common to have some issues with clubs applying for sanction early in the season and not being ready to move forward.
 - We have **70** of 93 pools approved for competition across Ontario.

V. Local Organizing Committee

A. 2018 OJI

- We have a signed LOU with Swimming Canada

 - ✓ This is a prestigious honour for S.O. and a testament to her hard work and dedication to past S.C. events as the LOC Meet Manager.
