- Insurance premium increase was lower than first anticipated and lower based on modified submission of registration numbers (previous masters stats were modified)
- 10% Increase in staff health benefits premium effective March 2018
- New Masters swimmer category approved Swim Ontario Masters Independent Swimmer \$75.00.
- The approved increase to the Move Us Forward Project was for meeting expenses and not consultant fees

5-2017:04.5 **Executive Director Report**

J. Vadeika distributed a written report prior to the meeting and summarized the following:

- A new Employment Standard law came into effect January 2018. Swim Ontario is in compliance with the ACT and is finalizing an education communication for clubs who may not be aware of the ACT and how it will be applied. As an example – use of contractors in the club setting; the ministry will now investigate the employer not the contractor.
- 2. Registration appears to be on track and will continue to monitor monthly with updates to the Board.
- Office Relocation A signed representation agreement has been initiated with the 3 parties - Coaches Association, Lacrosse Ontario and Swim Ontario for negotiations to go forward with ARTIS to renew office lease agreement
- 4. Complaint dispute John summarized the various complaints being dealt with.
- 5. Staff professional Development researching and collaborating with a company to create a potential customized delivery


i. In accordance with the provisions of the Nevada program, we will be using some Nevada funds to pay for SO tour team flights

4. Human Resources

- a. Employment Standards
 - i. In 2015, the Ontario Government announced a comprehensive review of issues affecting the modern workplace. Two advisors prepared a final report outlining 173 changes to the Employment Standards Act 2000 ("ESA") and the Labour Relations Act, 1995 ("LRA").
 - ii. The Government introduced an Act to amend the Employment Standards Act 2000 and the Labour Relations Act, 1995 and to make related amendments to other Acts, referred to as the Fair Workplaces, Better Jobs Act, 2017 ("Bill 148"). Several amendments in Bill 148 went beyond the recommendations in the Final Report signalling a clear intention to provide greater security for employees and the demands of unions.
 - iii. On November 27, 2017, Bill 148 received Royal Assent. Based on our internal review, Swim Ontario is compliant with new Bill 148
- b. Benefits
 - i. Notice received from Sterling Capital that an increase in approximately 10% beginning February this has been reported to Finance Committee
 - ii. We requested a status update from our Broker
- c. Staff Professional Development reviewing and negotiating possible PD with Stitt Feld Handy

7. Club Affiliation Status

i. ROCS Swimming – significant change (new owners) was approved with requirement to submit proof of dissolution of old entity by November 1 – proof has not been received yet.

8. Board Meetings

- i. Approved minutes have been posted with ED Reports
- ii. Confidentiality agreements and Offence Declarations/Police checks still in process

9. Office Relocation Update

- i. A strategy with Coaches of Ontario and Ontario Lacrosse to begin negotiations with ARTIS property owners for a rental agreement beyond August 2018 has begun.
- ii. We continue to be in discussion with ARTIS with the intent to negotiate as a single voice (strategy) of a group of three sport orgs.
- iii. This objective does have some logistical nuances however may pose the best opportunity to negotiate a congruent set of lease terms.
- iv. We have signed a representation agreement with CBRE West to represent the 3 sport orgs until May 14, 2018.

10. Insurance Renewal & Certificates

- i. Approved Masters Clubs Insurance information collected with affiliation documents and list of requests is compiled as received. List will be sent to BFL as approved, to prepare new certificates of insurance for Masters Clubs. The turnaround time is approximately two business days or less in some circumstances.
- ii. Renewal Impact As some of you may have read in the media, here is a link to a very recent legal finding of negligence resulting in a significant financial award... <u>http://leaderpost.com/news/local-news/jury-awards-paralyzed-regina-swimmer-turned-paralympian-more-than-9-million</u>. By the time the final award is calculated it is estimated that the award will be approximately \$14 M.
- iii. SC requested to raise the CGL liability policy currently at \$7M to \$10M. Our CGL policy is under an umbrella policy with Swimming Canada in order to maximize economy of scale and receive favourable policy rates. The following provinces are also participants, Swim Ontario, Swim BC & YK, Swim NB, Swim NFLD and Swim NS. FNQ only participates in the ADD policy. Like Swim AB, Swim Sask, or Swim MB etc. those provinces are insured by their governments and/or have separate policies.
- iv. SC has increased their D&O coverage from \$2M to \$5M. While we utilize the same broker, we get the same rate, however we are put under a different insurance provider. The rate for \$5 M is \$1.10 per registrant compared to \$0.65 for 2017-18 (marginal increase). This will result in an additional \$1000.00 for our D&O coverage. I will recommend to the Finance & Audit that we remain at \$2M until risk can be assessed at whether or not we need to increase our coverage.
- v. Our registration numbers for 2017-18 was adjusted by SC based on the adjustments in Masters Registration. This has alleviated the projected stress on the budget line item however we should plan for an increase to the 2018-19 budget line item as appropriate. Complaints, Disputes & Risk

- 1. Dispute between parents and club regarding the restriction on outside activities of swimmers. (17 parent complaints involving 9 swimmers)
- 2. Two complaints involving alleged inappropriate conduct by a coach (profanity and bullying behaviour) towards minor swimmers.
- 3. Non-registered individual providing coaching services to a Member Club during sanctioned swimming activities.
- 4. Harassment complaints brought as against Official. Behaviour complained of is verbal harassment and conduct constitutes harassment (non-sexual in nature).
- 5. Investigation of complaint as against Zach Hurd resulting from charge of sexual exploitation. Joint investigation with Club as to process moving forward. Responses to parent concerns and media inquiries. Consultation underway with SNC and CSCTA. (D&O Insurer and general liability insurer notified).







• February / March registration will be closely monitored as clubs will be given Officials Development Plan (ODP) compliance updates. This will encourage those that have not maintained current registrations of officials.

Officials Education

- Since November an additional 103 clinics have been registered with Swim Ontario. Total of 263 for the season so far. Central and Eastern regions have upcoming regional clinics in January and February. Most clinics were "in-person" clinics given by clubs with 3374 officials serviced.
- Level 1 clinics as E-learning modules have not been launched glitches still exist
 - The Swimming Canada OCRC December Bulletin communicated and addressed this
- Conducted 3 additional webinars with more scheduled for January and February using Contact North free webinar platform. Average number of attendees is 50. Not everyone that registers attends. We will continue the webinar deliveries and have other instructors learn the process.
- Clinics that have been identified as being good for webinar delivery: Meet Manager, Clerk of Course, CFJ-CJE, Recorder-Scorer and Chief Timer.

Provincial Sanctioning 2017-18 – as of January 3 2018

- 9 pending sanctions
- One sanction denied CPWD not ODP compliant (will work with them to complete an official's development plan and possibly will be granted exemption for the season).
- Mid-year Review of ODP numbers begins in Feb / March.
- 144 sanctioned meets have run so far
- 74 upcoming meets have been sanctioned

 - Post Meet Invoicing there are 10 outstanding Post Meet invoices

Coaching

- Registration
 - As of January 3 there are 828 Registered Coaches for the 2017-2018 season
 - 66.6 % or 543 are Certified at Level 1 Fundamentals or higher
 - 4.6 % or 38 have submitted their portfolios for marking
 - 7.8% or 65 are First Year, Level 1 Trained Coaches
 - 4.6% or 38 are Returning Coaches, Level 1 Trained, but not certified. Coaches have been notified of what they are missing for certification requirements.
 - 17.1% or 142 are untrained
 - 3 are Independent Coaches
 - As of January 3 there are 15.7% or 130 coaches in the system who have been entered, but registration is not complete
 - 54.6% or 71 are CSCTA Account Pending (have not completed their CSCTA registration)
 - 1 are CSCTA Pending (have not paid for CSCTA membership)
 - 33% or 43 are PSO Pending (have not provided VSC, paid, or both)
 - 11.5% or 15 are PSO/CSCTA Pending (have not paid Swim Ontario or CSCTA, probably haven't submitted VSC)
- Education

- Swim Ontario has offered 13 courses since September 1, 2017
 - 10 Swimming 101s
 - Central 3, Eastern 2, Huronia 1, North East 1, North West 1, Western 2
 - 2 courses were cancelled due to low subscription (Central, Northeast)
 - 1 course was offered at \$50 through National Coaches Week (Huronia)
 - 92 coaches trained
 - 1 Swimming 201
 - Central
 - 11 coaches trained
- Swim Ontario currently has upcoming courses being offered in
 - 101 Toronto January
 - 101 Windsor January
 - 101 Nepean February
 - 101 Mississauga April
 - 201 Nepean May
- Professional Development
 - Coaches are now required to collect a set number of points in a 5 year period to keep their certification active. Their five year period varies depending on their certification date. The earliest end date is January 2019.
 - Upon registration, staff have been sending coaches an email with their current point status, as well as a reminders of their expiry date and links to the opportunities to accumulate PD points.

Communications

- MailChimp for Mass delivery system
 - Approximately 98% of communication is successfully delivered
 - Approximately 60% of the communication delivered is opened by the recipient
- We continue to hear the complaint about lack of communication, however, we can't make people read the information that we distribute.
- Webinars Swim Ontario has started to use the Contact North webinar platform for officials training.


