



Officials Development Funding that can be applied for by Officials (Level 3/4/5) who are

Traveling to deliver clinics or observe the delivery of a clinic for certification requirements (Level 4/5)

- > 100 KM total trip

Traveling to mentor & be CC at competition for clubs in need of officials development (Level 4/5)

- Outside of region or overnight accommodations are necessary
- Host Club must apply for the need of the mentor
- Shared costs with Host Club

Traveling to Regional or Provincial Championship meets (Level 3/4/5)

- Advanced application required
- Minimum number of sessions 50% ***
- Outside of region with flight or >400 km
 - Maximum \$1,000
- Outside of region or overnight accommodations
 - Maximum \$650
- In region <100km
 - Maximum \$150
- Regional Meets: total allocated funds: \$2,000
- March Provincial Meets: total allocated fund: \$3,000
- Summer Provincial Meet: \$4,000

Traveling outside of region for RA for level 5 requirement (Level 4)

- Advanced application required
- Minimum number of sessions 50% ***
- Outside of region with flight or >400 km
 - Maximum \$1000
- Outside of region or overnight accommodations are necessary
 - Maximum \$650
- One time application

Traveling to a National meet to satisfy level 5 requirement (Level 3/4)

- Advanced application required
- includes OJI – excludes Mel Zajac
- Minimum number of sessions 4
- Outside of region or overnight accommodations are necessary
 - Maximum \$500
- In region – no accommodations required
 - Maximum \$100
- One time application

*** To receive the maximum funding the official must work a minimum of 80% of sessions.
Total funding will be prorated if less than 80%.



Officials Development Funding that can be applied for by Officials (Level 5 / WPS / OW)

Level 5 who will commit to national events attendance to gain the experience and be recognized for advancement past Level 5 certification

- Advanced application required
- 2 National Meet attendance the previous fiscal season (April to March)
- Minimum of 2 national events per fiscal season
- Minimum number of sessions 80% ***
- Funds disbursed after minimum 2 events within season is satisfied
- Outside of region/province or overnight accommodations are necessary
 - Maximum \$1,500
- In region – no accommodations required
 - Maximum \$250
- Each National Meet will be allocated a total funding amount and total funding will be prorated based on the number of applicants and funding. Shared accommodations is encouraged.

Level 5 WPS who are working towards WPS international certification and travel to WPS only events

- Advanced application required
- Must attend all required sessions
 - Maximum \$1,500
- One application per fiscal season (April 1 – March 31)

OW Level II official who are working towards OW Level III certification and OW FINA/AQUA

- Advanced application required
- Minimum of 2 events per season
- Funds disbursed after minimum 2 events within season is satisfied
- Must attend all days
 - Maximum \$1,000 per fiscal (April 1 – March 31)

FINA/AQUA official or WPS international official who are required to attend a National / International / WPS only event:

- Advanced application required
- Must attend all sessions
 - Maximum \$1,000 per fiscal (April 1 – March 31)
- Letter from Swimming Canada/WPS indicating requirement to attend and no funding will be provided will be part of the application

*** To receive the funding the official must work a minimum of 80% of sessions.

As Level 3 your goal is to

Help Club/Region

You can receive up to \$650 towards expenses to travel to regional championship meets

Help Region/Province

You can receive up to \$1,000 towards expenses to travel to regional or provincial championship meets.

You can receive up to \$500 towards expenses to gain National Meet experience required for Level 5 certification

As a Level 4 your Goal is to

Pursue Level 5

Help Region/Province

You can receive funding to offset travel expenses for an out-of-region Referee Assessment

You can received up to \$1,000 towards expenses to travel to regional or provincial championships meets or Ontario Junior International at TPASC

You can receive mileage expenses to deliver clinics when round trip is more 100 KM

If your Referee Assessment is at an event that requires a flight or more than 400 KM in distance you are eligible for up to \$1,000 to offset travel costs

You are eligible for up to \$650 to offset travel costs

Mentor officials

Within Province

A Host Club without a Mentor Official may be eligible to have you be the CC. Swim Ontario, with the club, would help offset travel expenses.

You can receive up to \$650 towards expenses to travel to regional championship meets

You can receive up to \$1,000 towards expenses to travel to provincial championship meets or Ontario Junior International at TPASC
