Swim Ontario President Report

2023-2024 continued to see Swim Ontario make progress towards achieving its vision of being a world leader in swimming excellence at all levels. Swim Ontario, in partnership with its member clubs, Swimming Canada, venues, and others, worked towards its mission of being a best-in-class provincial sports organization, which supports performance and participation for life. We have strived to provide educational opportunities, mentoring, responsible governance, and exceptional service to our members

This has been a team effort, and I would like to thank all our member clubs for their hard work and support during the past year.

An integral part of our success is our people, including our staff led by our CEO, Dean Boles. In addition, are the countless volunteers who make swimming work, including club administrators, officials, parents/guardians, and others – to each of you thank you.

I would also like to thank the hundreds of coaches, who everyday are on deck teaching and training our swimmers to be the best they can be. They not only train our resolute athletes to perform in the pool, but also impart important life lessons that will help shape them far into the future.

The Paris Olympics and Paralympics were a showcase of Canadian swimming, as both female and male swimmers performed admirably. That the Olympics, Canadian swimmers finished with eight medals, and additionally, either individually or relay teams, recorded six fourth place finishes and Canadian swimmers participated in finals 21 times. This was an incredible achievement and speaks to the hard work of our athletes, coaches, support staff and all the programming put in place to support them. Our Paralympic swimmers followed close behind with Canada earning 13 medals including 5 gold medals.

Now it is onto Los Angeles.

Highlights of our board and staff work during the past year includes:

- Attracting an increased number of competitive, precompetitive and masters swimmers to programs across the province
- Investing \$1,705,000 into programing for athletes, coaches, clubs, and volunteers
- Maintaining financial reserves that allow Swim Ontario to respond to unexpected challenges and to take advantage of emerging opportunities
- Responding successfully to a Swimming Canada data breach and supporting clubs to continue operations
- Introducing a new dispute resolution process that will provide direct support to clubs
- Successfully staging five provincial meets and supporting Swimming Canada to stage three national meets in Ontario, including the Olympic and Paralympic Trials
- Working with other sports organization, through the Aquatic Council, to seek new investments in the development of aquatic infrastructure

- Introducing new governance structures to better monitor financial, reputational, and other risks
- Introducing a new nominations process that aligns with best practice for PSOs and other not-forprofits
- Providing additional Swim Ontario staff resources to support clubs

The upcoming year will be one of change, and an opportunity to take different approaches and to seize new possibilities.

We anticipate that success at the Olympics and Paralympics will result in a surge of new entrants into our competitive and pre-competitive programs across the province. This will provide an opportunity for renewal and new beginnings, but it also will pose challenges as clubs deal with securing resources, both in terms of personnel and pool availability.

Clubs and regions will be operating within a new competitive calendar. It is hoped that fewer provincial properties will help facilitate the development of new competitive opportunities and provide clubs and regions the chance to introduce new and unique approaches to swim meet organization and participation.

Additionally, new sanctioning requirements are being introduced and development of the new official's pathway continues.

Swimming Canada continues the process of implementing REMS, the replacement for the RTR. Swim Ontario and club staff have undergone training in its use. Like any new project, we should anticipate some hiccups in the beginning, however, the system should prove an improvement over the functionality of the RTR.

We will also be taking the opportunity to update our 2021-2028 strategic plan so that it best reflects the current situation and positions us to effectively achieve our corporate mission and goals,

In closing, I would like to thank all of the board members for the support that they have provided me during the past year in my position as president. It is much appreciated.

This is who we are...

Swim Ontario is the non-profit sport governing body responsible for the organization and regulation of swimming in the province. Swim Ontario promotes excellence by structuring, regulating and supporting various programs, which encourage the maximum development of each individual swimmer through the Member Club. The organization is directed by a volunteer Board of Directors, several committees (both Board and Operational). The policies, procedures and operations are managed by a full-time professional staff working in a remote/in office hybrid model. Swim Ontario offices are located at the Toronto Pan Am Sports Centre in Scarborough.

This is what we do...

Swim Ontario is guided by its Strategic Plan. The current plan is driven by three priorities that form the foundation for success for the 2021-2028 period: Performance—Club Support—Organizational Excellence. Each priority is dependent on and overlaps with the others, and collectively they provide a powerful platform for Swim Ontario. Engage-Inspire-Empower is the fuel that drives those priorities forward. Every two years, a formal review of the Strategic Plan will be conducted. The first review, refreshed each of the priorities as well added language to reflect the current landscape driven by today's expectations. The next review this Fall will measure the outcomes of the previous four years and refinement for the next four years.

- Enhance Para swimming coach development through a focussed program in conjunction with Para sport partners and opportunities.
- Review and consider engagement in the Ontario Para Sport Games with the goal of developing the performance pathway for para swimmers and coaches.
- Support local clubs to help understand and create an inclusive environment that recognizes the value of diversity and equity.
- Develop policy and review current operational processes for continuous efforts to ensure diverse perspectives and lived experiences in the workplace.
- Influence and invest in Grassroots and Age Group Development.

As we continue to have our Strategic Plan guide the organization, we turn our intentions into actions during the 2023-2024 season in varying ways in order to bring the operations of Swim Ontario closer to the clubs and the clubs closer to the organization for a stronger Ontario swimming community.

Swim Ontario is proud to be a committed and recognized Performance Partner investing, supporting and leading the various performance pathways, towards the Paris and Los Angeles Olympic and Paralympic Games.

Swim Ontario is proud and grateful for having strong and respectable relationships with our Sport Partners. Years of mutual respect and support with Swimming Canada, Ministry of Sport (MTCS), Canadian Sport Institute Ontario (CSIO), Own the Podium (OTP), Ontario Para Sport Collective (OPSC), Canadian Swim Coaches Association (CSCA) and the Coaches Association of Ontario (CAO) have been valuable as we continue to work together through the challenges that are behind us and the new ones that arise as we move forward. These performance relationships also include our partner facilities—

Toronto Pan Am Sport Centre (TPASC), Markham Pan Am Centre (MPAC); Windsor International Aquatic and Training Centre (WIATC)

Key initiatives and actions in the 2023-2024 season:

- To bring the Swim Ontario organization in line with provincial legislation regarding by-laws, policies and best practices for a sustainable future, affording the best possible experience for all in a safe, responsible environment.
- We are pleased to grow our staff to help service all the needs and requirements of an everchanging sporting landscape. We welcomed Ali Gur to the staff in April as Events & Promotion Coordinator.
- A focus on the further development of Para Swimming in Ontario with programs such as 'Pools
 to Schools' and the REACH seminars continue to grow and gain momentum with many clubs.
 Momentum is developing for inclusion and integration for example, the Swim Ottawa club for
 creating a first-time opportunity for 20+ new swimmers with physical impairments. Integrating
 into the Grassroots development plan is proving to be successful.
- Swim Ontario Board and staff hosted three Presidents' Town Hall webinars including a Club Feedback Forum. As well updates for bylaw changes and other policy and governance status updates including ONCA (Not for Profit Corporations Act) for implementation October 2024; Code of Conduct adoption as well a 'best practices' in Welcoming and Belonging in the club setting.
- Swim Ontario continues to recognize and expand the leadership team (Board of Directors, staff and committees) in a learning forum in various areas for recovery, for growth and education. As there is a wide range of topics and strengths, we need guidance from experts to bring social interests and challenges to the forefront and add value to the 2021-2028 Strategic Plan and the actions required to be better. The Equity Diversity Inclusion (EDI) Committee of the Board presented a policy to continue the education and direction for the organization.
- Swim Ontario continues its leadership role with the Aquatic Sport Council of Ontario bringing the Aquatic Facility Resource project to where we are currently engaged with a government relations company Strategy Corp to do a multi level white paper and a strategy for Clubs, Cities and Municipalities to refer to as a current information tool to build new sport training friendly facilities. Thank you to Anne Bell and the ASC representatives for their go forward attitude.
- A "Think Tank" group of representatives from the Sport Development Committee, Regional Coaches, Officials' representation and Technical staff have reached its goal creating a new competitive structure including calendar, performance development and program enhancement for 2025-2028. Swim Ontario provincial competition properties will be Ontario Junior International (December), Ontario Age Groups (2 meets simultaneously March), Masters Provincials (April), Ontario Swimming Championships (July) and Open Water Championships (July).
- In partnership with the Ontario Aquatic Hall of Fame we are pleased to have three inductions at this year's Awards and Hall of Fame celebration. Debbie Wurzburger and Chris Chalmers from the London Aquatic Club, and Brittany MacLean from the Etobicoke Swim Club. All three Inductees are recognized through the Athlete category
- Swim Ontario and the swimming community of volunteers and officials have been extremely busy this past season hosting not only the scheduled provincial properties but that of the

national events including the 2024 Olympic and Paralympic Trials as a strong partner of Swimming Canada. The Ontario swimming community rolled up their sleeves working side by side with Swimming Canada, the Quebec swimming federation as well the TPASC staff for a very successful Trials. A big thank you to the host clubs: WS, MAC, ESWIM, PTBO, MUSAC and EOMAC stepping up to support the provincial properties as well the SCAR during the summer CSCs.

- We continue to invest in coach education and key learning experiences. The Next Gen coaching program saw its second year with 18 coaches with a mix of in-person and virtual sharing led by several notable mentors and experts. The Coach Accelerator Program welcomed another 12 coaches and saw it expand to the 201 level. The various camps and tours offered to swimmers led by our leading coaches also played well for all coaches to experience. Eight initiatives from local, to national and international provided educational experience to 125 swimmers and 30 coaches throughout the season.
- Our Officials committee was very active developing and servicing a significant growth in officials participation and certification at all levels with impressive numbers of 9,600 registered officials completing clinics and E-modules. We welcomed 24 new level 4 and 5 officials to the growing roster of skilled and experienced officials. Outstanding work by all. We look forward to the implementation of the new Officials' Pathway and introduction of new competition sanctioning requirements this season. Swim Ontario has been able to extend more financial support for development and reimbursement programming to the officials' community.
- We continue to have great relationships with our long-standing sponsors, Team Aquatic Supplies
 and Nothers The Award Store well into our second decade of support. Our agreement with
 ARENA was not renewed however we appreciate the working relationship we had with Pierre
 Vermette and his team for the past five great years.
- We continue to seek out new partnerships that will enhance our pursuit to be a best in class
 provincial sport organization. Most recently Speedo Canada have come to the Swim Ontario
 community supporting the Fundamentals Camp during OJI weekend and now we look forward
 to a four-year agreement spreading Speedo products and dollars across our performance and
 development programs.
- New Revenue Generation (NRG) Stream followed the guiding principles of the NRG initiative hosting Swim Ontario's first Golf Day Fundraiser the event grossed \$17,000 with good interest from outside the Ontario swimming community as well the friendly faces we see on our decks.

We continue to invest in the lifeline of our sport:

- Regional and provincial programming for Paralympic and Olympic stream coaches and athletes
- Master's programming
- Officials' development
- Coaches' development
- Club Development
- Regional development
- EDI initiatives
- Ontario Aquatic Infrastructure

With all this in mind, we continue to host virtual Swimming Info sessions each quarter delivering current information with a focus giving opportunity give feedback and share best practice amongst the community to help staff and committee members to plan and deliver all facets of the swimming program—when we hear from you, we listen and we value the feedback.

We will continue to offer educational spaces and pieces for clubs and its members throughout the upcoming season to continue to bring the 2021-2028 Strategic Plan into play. Our technical focus will be the competition and program calendar in the 2025-2028 period to align best with the Swimming Canada 'Canadian Way' national events calendar. We look forward to working with all to make this the manner we see swimming performance improve and advance.

There is much for all of us to do. As we take steps forward, we must continue to be nimble and adaptable, and in many respects for the years to come, striving to optimize our potential together. Promoting and sharing a values-based culture, strategies, goals and objectives in the pursuit of excellence in the performance arena, growth, sustainability and successful club businesses, supporting programs with a focus on the well-being of all who participate in the sport of competitive swimming here in Ontario and Canada. This is a huge ask, however we are sport people and we have learned to be strong, to be driven, to be resilient and to be resourceful and innovative.

Consider this:

Hard Work is a choice, Attitude is a choice, Discipline is a choice, Excellence is a choice. We believe we have a swimming community who share these time honoured values. We are **Stronger Together**!




Swim Ontario Finance and Audit Committee Report

The Finance & Audit Committee, including Tracy Bennett, Corrine Owen, Tym Barker, Andy Mitchell, Bud Seawright and Jamie Peetsma (Chair), brought a wide variety of business, municipal, and accounting expertise, as well as geographic representation from across the province. The committee had seven meetings this past year and provided approved financial statements to the Board of Directors on a regular basis.

This year Swim Ontario again retained the services of Aaron Reilly, of Reilly Back, LLP to perform the annual audit. The audited financial statements for the year ending 31 March 2024 show total assets of \$3.3MM which is slightly higher than the previous year \$2.9MM. This is attributed to Accounts Payable, having a higher balance. The organization has a current Operational Reserve of \$2.16MM, of which \$446,052 has been internally restricted by the Board of Directors, and the remaining unrestricted assets have no internal restrictions.

Total operating revenues for the fiscal year were \$ 3.54MM which is approximately 111% of prior year \$3.182MM. Total expenses for the fiscal year were \$ 3.34MM, leaving an operational surplus of \$199,561 this year.





Swim Ontario is trending at a baseline with approximately 43% of revenues coming from registration fees, 17% from Government Grants. 37% from Competition fees and 3% from other revenue generating activities. Leadership exercised fiscal responsibly and stayed within budget ending the year with a surplus.

The 2024-2025 annual budget was recommended for approval by the Finance & Audit Committee and approved by the Swim Ontario Board of Directors. The budget went through several iterations trying to balance operational support, strategic and club spending.

The Finance & Audit Committee and senior management prepared a budget at 100% revenue where registration has a 5% increase and competition revenues at baseline. An increase in expenses was also introduced to ensure that Swimming in Ontario was being supported as we look for growth in the sport.


This approach resulted in a budget for 2024-25 where overall total revenues are budgeted at \$3.53MM and expenses at 3.66MM, thus budgeting a deficit of 125K which would be covered by Operational Reserve funds

I would like to thank Dean Boles (CEO/CTO) and Darin Muma (COO) for all their hard work and many revisions that resulted in a well thought out budget to support the vision of the organization moving forward as we look for growth in Swimming.

Members should be aware that although Swim Ontario has a Healthy Balance sheet, the demands on both finances and staff resources will continue to increase to support the growing number of "Complaints, Discipline, and Appeals" issues. The financial risks relating to complaints have not been too onerous this year, but the number of issues and costs continue to rise, and although the organization's insurance coverage is comprehensive, there is always the possibility of financial risk.

I would like to thank the members of the 2023-2024 Finance and Audit Committee for their time, insight, and effort during this past year. Also, many thanks to Swim Ontario staff Heather Dwinnell, and accountant Al Versi, for their diligent work and guidance throughout the year.

The Policy and Governance Committee is responsible for advising the Board in fulfilling its responsibilities relating to governance and its governing documents including policies and by-laws. In fulfilling this mandate, and with the assistance of staff, the Committee performs the following key tasks:

- provides expertise to enhance the quality of Board discussion on policy and governance matters, and facilitates effective Board decision-making in these areas;
- advises the Board on the adequacy and effectiveness of Swim Ontario's key governing documents and framework policies;
- recommends to the Board, as required, amendments to its By-laws; and
- performs such additional tasks as may be delegated to the Committee by the Board from time to time.

Through the term of this committee the following products were created, reviewed and/or updated with the support of the committee:

- the committee's Terms of Reference;
- the Harassment policy;
- the Code of Conduct;
- the Complaint, Dispute Resolution and Appeals policy;
- the Nominations policy;
- the EDI policy;

Under the direction of the board the committee has also initiated work to create a CEO performance review framework expected to be completed under the new term of this committee.

The work of the committee could not be completed without the full support of Swim Ontario staff, including Darin Muma, Heather Dwinnell, Brian Ward, and Dean Boles as well as our legal support team. And I would like to take this opportunity to acknowledge my sincere appreciation to our committee members: Ahmed Abdelfattah, Leslie Carter, Andrea Jurenovskis, Janet Morrison, and Tobias Oriwol.

Swim Ontario Nominations Committee Report

Members: Andrea Jurenovskis (Chair), Anne Bell, and Matthew Dans

Duties and Responsibilities:

The Nomination Committee (the Committee) is charged in the corporate by-laws to:

"Nominations Committee is responsible for ensuring, on a continuing basis, that candidates for the Board of Swim Ontario are qualified, skilled and diverse persons capable of, and committed to, providing effective leadership to Swim Ontario"

In carrying out its responsibilities, the Committee identified the following priorities:

- 1. Review the policy relating to the nomination and election of eligible Director candidates and make changes, where necessary, to align it with industry best practices;
- Encourage greater diversity on the board. This includes representation from the ethno-racial community, indigenous individuals, persons who identify as LBGTQ, persons with a disability and other identifiable groups.
- 3. Strive towards a gender balance that better reflects the swimming community;
- 4. Increase geographic representation;
- 5. Recruit individuals with desired core competencies; and
- 6. Provide relevant, timely information about the candidates to the electors.

The Committee also updated their Terms of Reference and worked with the Policy and Governance Committee to:

1. Update the Policy on Determination of Eligible Director Candidates (the Policy).

Available Positions:

In 2024, four positions will be elected to the board. Three individuals will be selected to serve three-year terms replacing individuals whose terms have expired, and one individual will be elected to a two-year term and represents a Director's resignation from the Board.

With respect to the two-year term, rather than invoke bylaw 4.06 (c) and appoint an individual to the Board following the resignation of one of its Directors, the Board decided to fill this position by adding it to the available seats for general election at the AGM.

Committee Work:

The Committee consulted with legal counsel, the Policy and Governance Committee, and the Equity, Diversity, and Inclusion Committee, and obtained the approval of the Board to make changes to and update the Policy to reflect industry best practices.

The Committee solicited nominations through social media and communications with individuals involved with the many aspects of Swim Ontario activities. We are pleased that as of August 26th, seven individuals have submitted valid applications to serve on the Board.

Pursuant to the terms of the updated Policy, the Nominations Committee has identified select candidates from the pool of applicants to recommend to the Membership for election. The Nominations Committee's reasons for recommending select candidates can be found below. The application materials for <u>all</u> eligible candidates who submitted their completed applications on or before August 2, 2024, have been posted on Swim Ontario's website HERE.

Recommended Candidates:

This year, the Nominations Committee has recommended a candidate for every available seat. The Committee feels strongly that the recommended candidates have a personal connection to Swim Ontario and its activities and offer valuable professional experience that addresses the needs of the Board and the gaps in the Board's skills matrix. Importantly, after interviewing the candidates, the Nominations Committee believes the recommended slate standout as ambassadors for the organization.

Andy Mitchell

Over the past two years, Andy has demonstrated effective and strategic leadership as the President of the Board of Directors. Prior to that, he was a member of the Board of Directors and served on Swim Ontario's Finance Committee. Re-electing Andy will ensure continuity on the Board of Directors and preserve institutional knowledge. Besides being actively engaged in the swimming community (as a club administrator, parent, and Level 5 official who officiates over 200 sessions per year) Andy offers past governance and policy experience with Swim Ontario, and other not-for-profit boards. Although now retired, Andy provides a unique perspective having had a long and successful career in the public service, serving as an MP for 13 years, a member of the Federal Cabinet for eight years, Mayor and Deputy Mayor of Selwyn Township, Chief of Staff for the Leader of the Opposition, and Senior Advisor within the Ontario government.

Robert Giggey:

As the current Vice-President of the Board and Chair of the Policy and Governance Committee, Robert has proven his ability to lead effectively. Robert has significant governance experience serving on corporate, public, and not-for-profit Boards of Directors. Robert has been actively engaged with the leadership of Swim Ontario but also with its activities as a swimmer, parent, official, and coach. He provides a valuable experience and perspective for the Board.

Taylor Bond:

Taylor is a former competitive swimmer, having swam across Canada at the age-group and collegiate levels and lived around the world. Taylor's professional attributes include a professional designation in marketing and he has professional fundraising and operational experience as a founder and member of the executive in a private corporation. These professional qualities and aptitudes are currently lacking on the Board. Taylor has substantial not-for-profit and board experience, with significant experience in developing and implementing DEI initiatives. He would provide a unique and important perspective to Board discussions around Swim Ontario's new Diversity, EI policy and the practical considerations around its implementation. Notably, Taylor is an independent candidate. He can provide a non-biased and objective perspective to Swim Ontario issues as neither he, nor any of his close family, have been affiliated with any clubs over the past several years.

Ahmed Abdelfattah (two-year term):

Ahmed has been very involved in the swimming community for many years, having swam at the National level for Egypt prior to immigrating to Canada and, subsequently, continued his involvement as a parent and official, reaching his Level 5 in 2018. Notably and demonstrating his lifelong commitment to the sport, Ahmed has remained involved in Swim Ontario and Swimming Canada activities despite his children learning to love a new sport and has volunteered his time and has been a valued member of two Swim Ontario committees over the past year (the Policy & Governance Committee and the Officials Committee). Ahmed has prior governance experience serving on other not-for-profit and public Boards of Directors. His professional skills and experience includes financial management, business strategy and planning, managerial responsibilities, risk management, and policy development; all competencies which would complement the skills of the other Directors on the Board and ensure continuity in essential skills required for an effective Board as the terms of other Directors cycle through to termination. Ahmed is being recommended for the two-year term because he expressed this as his preference.

Swim Ontario Officials Committee Report


The Swim Ontario Officials Committee (SOOC) serves as an advisory body to the Chief Executive Officer (CEO) of Swim Ontario, offering guidance on officiating and competition matters within Ontario. The SOOC operates in alignment with the Swimming Canada Officials, Competitions, and Rules Committee (OCRC).

This season, Swim Ontario once again experienced a notable surge in registrations, bringing the total number of registered officials to approximately 9600. Among them, over 2300 individuals achieved certification as Level 1 officials. We observed a 20% increase in the overall registration numbers for Level 2 to 5 officials, driven by clubs making corrections based on reports of their officials' progress. Focused mentorship and evaluations led to significant growth in the number of newly certified Level 2 officials. Additionally, there were small increases at Levels 4 and 5, while the number of newly certified Level 3 officials experienced a decrease compared to last season.



Swim Ontario remains steadfast in its commitment to developing and supporting swim officials at all levels of competition. Recognizing the critical role of proper training and opportunities for advancement, the Swim Ontario Officials Committee (SOOC) implemented some new initiatives deemed at creating an inclusive and supportive environment for officials across the province. Financial assistance continues to be available to deliver clinics, conduct referee assessments, and facilitate attendance at regional, provincial, and national competitions for mentorship and experience. Over \$58,000 was dispersed in funding for travel.

Officials Development - \$58,000+ April 1, 2023 to March 31, 2024



In preparation for the upcoming season and the introduction of the new Officials Development Procedure (ODP), four progress reports have been sent to clubs to ensure they are well-prepared. The ODP, set to take effect in the 2024-2025 season, will shift to a tiered competition eligibility system based on the number of qualified and certified officials in various roles, rather than club size. This change will enable clubs to continue developing their officials and hosting competitions without limitations. The new ODP encourages clubs to actively engage their officials in progressing through assigned roles at competitions, complementing their ability to host and assist at meets.

The SOOC has also played a pivotal role in ensuring that Swimming Canada's new official certification pathway is being developed in a way that clearly defines the different positions and options available to both new and existing officials. By providing training materials and guidance, the SOOC aims to contribute to a comprehensive and inclusive certification pathway that meets the needs and aspirations of all swimming officials.

Throughout the past season, multiple updates to the rule book were released to incorporate ongoing changes, including revisions to World Aquatics and Swimming Canada rules. Another update is anticipated in the coming season to ensure that all officials are working with the most up-to-date information. Along with these rule book updates, numerous resources and forms were revised to reflect the changes. Notably, the Referee and Starter Assessment Forms underwent a comprehensive review and were published in February. Additionally, a new "Navigating Scenarios at Competition" webpage was launched, supported by a dedicated working group to manage and provide guidance on various scenarios. The SOOC also played a key role in developing the new Swimming Canada infraction reference card, which has now replaced the Swim Ontario version.



Risk Management Committee Report

Thank you to Anne Bell, Amy Watt, Leela D'Cruz, Brian Ward and Swim Ontario Legal Counsel Erin Durant for serving on this committee, lending their expertise and the gift of their time and commitment to risk management for Swim Ontario.

The RMC met four times over the 2023-2024 swim season as an Operational Committee of the CEO. Our primary task was to review and update the Swim Ontario Risk Matrix with a lens on risk mitigation strategies such as policy, procedure, insurance coverage and operations.

The committee also advised and assisted the CEO, the Swim Ontario Board and its Standing Committees in addressing any new or developing risks to either the corporation of Swim Ontario, or the larger swimming community.

The RMC was also able to assist the EDI Committee, and Policy and Governance Committee with input into development of the EDI policy and the Complaint, Discipline and Appeal Procedures. We also frequently reviewed the Risk Matrix to ensure that any risk was being managed appropriately.

Beginning in the 2024-2025 swim season, the RMC will become a Standing Committee of the Swim Ontario Board of Directors with a new title and new terms of reference.

Para Development Project Report

During the 2023-2024 season multiple exciting para development initiatives took place to promote, develop and enhance para swimming development in Ontario.

These initiatives include:

- The Becoming Para Ready workshop, which provides clubs and coaches with areas of consideration before working with para swimmers, was hosted for the second time with 16 clubs participating.
- The Pools to Schools project, which connects schools with a virtual para swimming athlete
 presentation and disability awareness and education program, was run for the third school year
 with 60 presentations given to over 1400 students and teachers.
- Two para swimmer development camps, along with the OJI Fundamentals Clinic, were held to provide para athletes and coaches with educational and community building opportunities.
- A tour team of nine athletes represented Swim Ontario at the Ken Demchuk International Invitational.

The number of para swimmers in the province continues to increase with fifteen swimmers applying for Level 1 Classification between January - July 2024, six swimmers went through the Level 2 classification process and five Ontario swimmers completed the Level 3 classification process during the 2023/2024 season.

Through support from Swim Ontario, two clubs started new Introduction to Para Swimming programs, and Swim Ontario continues to build new partnerships with organizations who work with individuals with disabilities such as the Toronto Accessible Sport Council with the initiation of the GTA Introduction to Para Swimming project.

Ontario Aquatic Sport Council Report

Expanding and Improving Aquatic Infrastructure

Swim Ontario understands the challenges that its members experience in accessing appropriate and safe pool space for training and competition. For this reason, investments have been made to better understand the issues and opportunities available to municipalities and other operators to maintain and expand access for other sports and other aquatic programs.

This important work has been undertaken as a member of the Aquatic Sport Council (Council). The Council is comprised of representatives from:

- Ontario Artistic Swimming (formerly Synchronized Swimming)
- Dive Ontario
- Lifesaving Society Ontario (Lifesaving Sport)
- Parks & Recreation Ontario
- Ontario Water Polo
- Swim Ontario

In 2023 the Council collectively funded a study undertaken by Aquatic Associates Inc. under the leadership of Tim Hamel. The study explored the number, features and state of existing pools, comparisons with other provinces, geographic gaps based on population and the configurations best suited to each of the member sports. This report is available HERE. It has been shared with government and municipal stakeholders and formed the basis for a second project in 2024. This report was also an influencing factor in the recent announcement by the Ontario government of \$200 Million to be invested in recreation facilities.

In June 2024, again based on a pro-rated cost sharing strategy, the Council engaged the services of StrategyCorp Inc. in the development of a position paper and strategy designed to share the compelling reason for the building of, and refurbishment of, aquatic sport infrastructure. Where the first project looked at the current state, the work of StrategyCorp Inc is to present reasons to governments for investment in more and improved pools – not just for sport but also for the many other good reasons to expand aquatic infrastructure – learn to swim, rehabilitation, healthy aging, recreation, etc. The final report is expected at the end of the year and 2025 will see the launch of the strategy.

INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the financial statements of Swim Ontario (the "Organization") which comprise the statement of financial position as at March 31, 2024 and the statements of operations, changes in net assets, and cash flows for the year then ended and notes to the financial statements, including a summary of significant accounting policies.

In my opinion, the accompanying financial statements present fairly, in all material respects, the financial position of Swim Ontario as at March 31, 2024 and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations ("ASNPO").

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Organization in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with ASNPO, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Organization's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Organization or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Organization's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. However, future events or conditions may cause the Organization to cease to continue as a going concern.

Notes to Financial Statements For the year ended March 31, 2024

1. Nature of operations

Swim Ontario, (the "Organization") is a sports governing body responsible for the organization and regulation of amateur competitive swimming in the province of Ontario. The Organization is incorporated without share capital under the laws of Ontario as a not-for-profit organization and is exempt from income tax under section 149.1(1) of the Income Tax Act.

2. Summary of significant accounting policies

a. Basis of Accounting

These financial statements have been prepared by management in accordance with Canada accounting standards for not-for-profit organizations ("ASNPO") in Part III of the CPA Canada Handbook.

b. Revenue recognition

The Organization follows the deferral method of accounting for contributions which include support from the public and government. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Endowment contributions are recognized as direct increases in net assets.

Income from investments is recognized as revenue when earned, including the unrealized portion of capital gains.

Fees and merchandise sales are recognized as revenue when received.

c. Cash and short-term investments

Cash and short-term investments includes bank balances, high interest savings accounts and guaranteed investment certificates with a maturity date of one year or less. Cash subject to restrictions that prevent its use for current purposes is included in restricted cash.

d. Equipment and other capital assets

Equipment and other capital assets are stated at cost. Amortization is calculated on the straight-line basis annually in amounts sufficient to amortize the cost of the assets over their estimated useful lives as follows:

Office furniture and equipment 10 years Leasehold improvements 5 years Computer equipment 3 years

e. Financial instruments

Initial and subsequent measurement

The Organization initially measures its financial assets and liabilities at fair value, except for certain related party transactions that are measured at the carrying amount or exchange amount, as appropriate.

The Organization subsequently measures all its financial assets and liabilities at cost or amortized cost.

Financial assets and liabilities measured at amortized cost include cash and cash equivalents, accounts receivable, and accounts payable and accrued liabilities.

Impairment

For financial assets measured at cost or amortized cost, the Organization determines whether there are indicators of possible impairment. When there is an indicator of impairment, and the Organization determines that a significant adverse change has occurred during the period in the expected timing or amount of future cash flows, a write-down is recognized in income. If the indicators of impairment have decreased or no longer exist, the previously recognized impairment loss may be reversed to the extent of the improvement. The carrying amount of the financial asset may not be greater than the amount that would have been reported at the date of the reversal had the impairment not been recognized previously. The amount of the reversal is recognized in income.

f. Use of estimates

The preparation of the Organization's financial statements, in accordance with ASNPO, requires management to make estimates and assumptions which affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses for the year. Actual results could differ from these estimates.

g. Contributed services

Volunteers contribute many hours annually to assist the Organization in carrying out its activities. Because of the difficulty of determining their fair value, contributed services are not recognized in the financial statements.

h. Impairment of long-lived assets

Equipment and other capital assets subject to amortization are tested for recoverability whenever events or changes in circumstances indicate that their carrying amount may not be recoverable. An impairment loss is recognized when the carrying amount of the asset exceeds the sum of the undiscounted cash flows resulting from its use and eventual disposition. The impairment loss is measured as the amount by which the carrying amount of the long-lived asset exceeds its fair value.

5. Swimming Natation Canada fees

Swim Ontario acts as agent in collecting registration fees on behalf of Swimming Natation Canada (SNC). Total registration fees collected amount to \$537,568 (2023 - \$952,084). SNC issues invoices for their registration fees bi-annually in September and March. The amount payable to SNC as at March 31, 2024 is \$1,019,693 (2023 - \$906,997).

9. Financial instruments

a. Market risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices.

To manage the market risk, the Organization hires an outside investment manager who has regular meetings with management.

There have not been any changes in the risk from the prior year.

b. Interest rate risk

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in the market interest rates. The Organization is exposed to interest rate risk on its fixed and floating interest rate financial instruments. Fixed-interest instruments subject the Organization to a fair value risk while the floating rate instruments subject it to a cash flow risk.

The Organization mitigates interest risk on investments by diversifying the durations of the fixed-income investments that are held at any given time.

There have not been any changes in the risk from the prior year.

c. Other price risk

Other price risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices (other than those arising from interest rate risk), whether those changes are caused by factors specific to the individual financial instrument or its issuer, or factors affecting all similar financial instruments traded in the market. The Organization is exposed to other price risk through its investments in quoted shares.

The Organization manages other price risk through asset allocation and maintaining a portfolio that is well diversified on both a geographic and industry sector basis.

There have not been any changes in the risk from the prior year.
