### Sanction Applications Notes

- The next few pages outlines the different type of meets and accompanying sanctions available for Age Group Clubs, Varsity Teams and Masters Clubs.
- Each type lists restrictions, deadlines for sanction application, template meet package and post meet fees payable to Swim Ontario.
- For In House competitions or Time Trials, the online Jotform must be used when creating the meet package. Creating the meet package with the online form is NOT the sanction application. The meet manager would need to login to their Meet Manager account on the REMS and submit a sanction application with the meet package PDF created with the jotform.
- For Varsity Dual/Tri meets that are 1 session long only, we ask that you use the Jotform available.
- All other types of sanctions can use the Google Doc template as a guide. Make a copy of the Google Doc, rename it and complete where necessary. Then create a PDF (File/Download/PDF or File/Print/PDF).
