### SCREENING REQUIREMENTS ([HERE](#))

Clubs are responsible for ensuring that all employees, board members, volunteers or other service providers who are in designated positions, are required to provide valid Security Screening documents or in years 2 and 3, an Offence Declaration as outlined in the [Screening Requirements Procedure](#) and these are on file at the time they register their club for the current year. Swim Ontario may request at their discretion that Clubs provide copies of a CRC, EPIC or Offence Declaration in their possession.

### CODE OF CONDUCT AND ETHICS FOR ALL PARTICIPANTS INCLUDING PARENTS/GUARDIANS ([HERE](#))

The Club agrees that all swimmers, parents, officials and coaches will abide by the Code Of Conduct And Ethics For All Participants including Parents/Guardians. The club acknowledges receipt of this Code and further agrees to inform all members of the club.

### SWIMMER, COACH AND OFFICIAL REGISTRATION AGREEMENT

The Club acknowledges and will abide to the commitment of registering **ALL** swimmers (including but not limited to all competitive, pre-competitive, development recreational, learn to swim), coaches, and officials within 2 weeks of commencing activities with Swim Ontario and Swimming Canada. **NOTE: Participants MUST have an “active” status in the REMS in order to continue with activities BEFORE the two week grace period has ended.**

### ADDITIONAL USER – REMS ADMINISTRATOR ACCOUNT

The Club acknowledges its commitment to collect signed [ADDITIONAL USER – REGISTRATION SYSTEM ACCESS COMPLIANCE DECLARATION](#) from each REMS user, including but not limited to the Team Manager, Meet Manager, Officials Administrator, and any other individuals to whom the club grants access to the REMS system. These declarations must be completed and on file for each user before access is granted.

### INCORPORATION

All clubs must be incorporated. By signing the declaration you are confirming that there have been no changes to the club's incorporation since the original documents were submitted to Swim Ontario and a certificate of status has been submitted to Swim Ontario. The Certificate of Status provides the current status of the corporation (active, dissolved or in default). To order the certificate please see government website ([federal](#) or [Ontario](#)). Please ensure that your club provides updates to the club's incorporation information (i.e. Directors & Officers) to the Ministry of Government Services ([federal](#) or [Ontario](#)).
